UC Clermont Scholarships: How to Apply

Assemble all scholarship application documents and turn them in together as a packet. Scholarship application packets that are not complete will not be considered by the selection committee.

A completed scholarship application packet includes:

- A completed scholarship application. Please check off all of the scholarships you are seeking and for which you are eligible per the descriptions.
- One letter of reference from a teacher, counselor or employer. Reference letters from relatives are not allowed.
- Complete a one-two page typed, double spaced essay about yourself. Handwritten essays will not be considered.

Please make sure to include in the essay:

- academic goals
- career goals
- community service
- leadership and/or school activities
- why you are attending UC Clermont College
- special circumstances

Other criteria:

- All scholarship applicants must have a completed UC Clermont admission application on file with Enrollment and Student Services prior to submitting a scholarship application. **Scholarship applicants without a completed UC Clermont admission application will not be considered by the selection committee.** A completed admission application includes:
 - admission application to UC Clermont
 - admission application fee
 - official high school transcript or GED scores
 - official college transcript(s) (if applicable)
- All scholarship applicants must have a 2.5 GPA unless otherwise noted.
- All scholarship candidates must be enrolled in a degree-seeking program at UC Clermont by Fall Quarter 2010.
- Priority is given to full-time students
- All scholarship application packets must be received by 5 pm on **April 2, 2010.**
- Unless otherwise noted, awardees will be notified by **April 30, 2010.**
- Students may apply for all scholarships for which they are eligible. Alternate recipients are selected in the event that awards are not used.

Scholarships

1. Academic Scholarship (N, \$1,000)

Academic Scholarships are awarded to graduating seniors who have ***maintained at least a 3.5 GPA*** from high schools in counties served by the UC Clermont community.

2. Advantage Scholarship (N, \$500)

Graduating seniors involved in ***extra-curricular activities*** while in high school are eligible for this scholarship.

3. Alumni Scholarship (N/C, \$500)

Established by UC Clermont College alumni, ***any UC Clermont College student*** is eligible for this scholarship.

4. Auxier Gas Scholarship (N/C, \$1,000)

Auxier Gas, an active Batavia community member, provides scholarship funds each year to a student ***majoring in business or aviation.***

5. Batavia Rotary Scholarship (N/C, \$1,000)

The Batavia Rotary Club has been in existence since 1938, and honors founder Harry Kahle with this scholarship. Rotary provides humanitarian service, encourages high ethical standards in all vocations, and helps build goodwill and peace in the world as well as in Clermont County. The Batavia Rotary provides this scholarship each year to a ***Clermont County resident*** who provides “service above self” through ***community service and volunteerism.***

6. Bauer Family Scholarship (C, \$500)

Dr. Jeff Bauer, Associate Professor of Management & Marketing at UC Clermont College, along with his family, provides this scholarship for a ***full-time second year Business major who has maintained a minimum 3.0 GPA and actively volunteers in the community.***

7. Business, Law, and Technology Scholarship (C, \$500)

The faculty representing the Business, Paralegal, and Information Technology programs provide this scholarship for a ***full-time student majoring in a program offered by the department who has maintained a minimum 3.0 GPA after completing a minimum of 12 credit hours.***

8. Carey-Steck Family Scholarship (R, \$1,000)

The Carey and Steck families, committed to the value of liberal arts education, have named a scholarship in honor of their grandmothers who instilled those values. Eligible students are those who had ***their college education interrupted and were not able to attend in the 2009-2010 academic year*** (or longer), due to the need to work or raise a family. They must have maintained at least a 2.75 GPA when last in school.

9. Clermont Chamber of Commerce Scholarship (N/C, \$1,000)

The Clermont Chamber of Commerce’s purpose is to support business and industry in the county. Two scholarships are awarded each year to students ***employed by a Chamber member*** to assure an educated workforce in the community.

10. Clermont County Citizen’s Law Enforcement Association Scholarship (N/C, \$1,500)

The Clermont County Citizen’s Law Enforcement Association provides this scholarship for a Clermont County resident who agrees to actively ***seek employment with a law enforcement agency in the county*** and to serve two years with that agency.

11. Clermont Home Builders Association Scholarship (N/C, \$500)

The Clermont Home Builders Association provides this scholarship to eligible students pursuing a degree in *engineering, CAD, or business related fields* with an interest in the building/construction industry.

12. Clermont Philharmonic Orchestra Scholarship (N, \$500)

Clermont Philharmonic Orchestra not only provides professional quality concerts, but also serves as a leader in supporting music education for Clermont County schools. Graduating seniors from a Clermont County high school who have *participated in some form of musical group consistently during high school* (includes band, choir, church groups, orchestra, ensembles) are eligible for the scholarship.

13. College Tech Prep Scholarship (N, \$1,000)

College Tech Prep programs prepare high school students for employment requiring a technical education. Entering students who have *participated in high school Tech Prep programs*, and plan to continue their education in a technical field, are eligible for this scholarship.

14. Professor Maryl Fletcher DeJong Memorial Scholarship (C, \$500)

The current and emeriti faculty of the college provide this scholarship for a *full-time student majoring in a Fine Arts program offered by the college who has maintained a minimum 3.0 GPA after completing a minimum of 24 credit hours*. In keeping with Professor DeJong's interests, applicants should also demonstrate involvement in one or more of the following:

- Student activities on the Clermont College campus
- Involvement in the community
- Fine Arts
- Education
- International Relations

15. Gajus Memorial Scholarship (C, \$500)

Carl E. Gajus, a former UC Clermont education professor, made it possible for education majors at two-year colleges to participate in Phi Delta Kappa, the international education honorary. *Phi Delta Kappa student members who have completed at least 36 credits with a minimum 3.0 GPA* are eligible for this scholarship.

16. Kelley Career Scholarship (N/C, \$500)

Wanting to provide young adults in the workforce with an opportunity to go to college, Blaine Kelley, of UC Clermont Enrollment and Student Services, provides a scholarship for an individual who *delayed entry into college after high school*. Eligible candidates must *major in one of the career-oriented* academic programs.

17. Kerr Danahy Scholarship (N/C/R, \$1,000)

Lindsay Kerr Danahy, a professor in Business Information Technology, created this scholarship to ensure that an *eligible BIT student who interrupted his/her college education* to work or raise a family had the financial means to complete the degree.

18. L3 communications/KDI Precision Products, Inc. Scholarship (N/C, \$1,000)

As a leading employer in Clermont County, L3 communications/KDI Precision Products wanted to ensure that their *employees or employee family members* had the financial opportunities available to pursue a college education. Eligible candidates must *have a minimum 3.0 GPA*.

19. Lindell Family Scholarship (N/C, \$1,000)

Carl and Ann Lindell wanted to give back to the community and company that have given them so much. They created a scholarship to aid *L3 communications/KDI Precision Products, Inc. employees and their family members* with tuition to UC Clermont. Students with a *minimum 3.0 GPA and a demonstrated financial need* are eligible for this scholarship.

20. Lykins Oil Company Scholarship (N/C, \$1,000)

Lykins Oil Company provides superior quality and sound carrier services for today's petroleum industry and petroleum end users. Eligible candidates are new or current UC Clermont College students who are *residents of Clermont or Brown counties*.

21. Marriott Scholarship (C, \$1,000)

Former principal in elementary schools throughout the world, Keith Marriott, recipient of a UC Clermont Instructor of the Year award, knows the work required to make an exceptional educator. Keith and Peg Marriott have created two scholarships to assist future educators in obtaining their degrees. *Scholarships are awarded to rising second year education majors*.

22. McDonough Scholarship (C, \$1,000)

Former Dean Jim McDonough and his wife Kathryn have established a scholarship to help single parent students complete their education. Eligibility is for a student who has a *minimum 3.5 GPA and is a single parent* with child custody.

23. The Midland Company Scholarship (N/C, \$1,000)

A local insurance company, the Midland Company, provides a scholarship to assist *full-time students* in achieving their academic goals. Eligible candidates must *maintain a minimum 2.5 GPA*.

24. Peters-Jones Scholarship (N, \$1,000)

Edith Peters-Jones was the first dean of UC Clermont and the first woman dean of a non-nursing college in Ohio. Her passion for education helped to develop the college into what it is today. In the true nature of Dr. Peters-Jones, this scholarship is available to *entering freshman in pursuit of their career and academic goals*.

25. Post-Secondary Enrollment Options Program Scholarship (N, \$500)

The Post-Secondary Enrollment Options Program (PSEOP) provides local high school students with the opportunity to take college courses while still in high school. A scholarship is awarded to every entering freshman who *participated in the UC Clermont College PSEOP and maintained a 3.0 college GPA, with a minimum of three classes completed*.

26. River Hills Bank Scholarship (N/C, \$1,000)

Business majors are eligible for this scholarship provided by River Hills Bank. A community member for 100 years, the bank believes in supporting *Clermont County residents* in meeting their academic goals.

27. Charles E. & Justine S. Romer Scholarship (N/C, \$4,542)

Charles and Justine Romer want to ensure students pursuing a college education have the financial means to meet additional expenses associated with attending college. Eligible candidates must be *academically achieving students*.

28. Santoro Engineering Scholarship (N/C, \$1,500)

As a civil engineer, surveyor and community leader, Angelo Santoro wants to help future engineering students reach the professional goals that he has experienced in his career. Eligible students for this scholarship must be in an **engineering-related major** (ex. CAD, CIS, CSST, CNS, and Pre-Engineering).

29. Sauls Family Scholarship (N/C, \$1,500)

Jim, Sr. and Vivian Sauls believed in investing in the community and in being actively involved to better the quality of life for those around them. Eligible recipients of this scholarship are **actively engaged in volunteer efforts within their community**.

30. Thomaston Woods Scholarship (N/C/R, \$1,200)

The goal of St. Thomas Housing Corporation and Thomaston Woods Apartments is to provide affordable, safe, quality housing for individuals and families who seek an opportunity to strengthen their lives. Four scholarships are awarded to **Thomaston Woods residents** enrolled as full or part time students at UC Clermont College.

31. UC Clermont College Scholar (N, \$3,000)

UC Clermont College Scholars are students who excel academically and also demonstrate leadership, service and commitment to their communities as well. Each year, UC Clermont awards 10 scholarships to **graduating high school seniors who not only are in the top tier of their class, but are also actively engaged members in their community**. This scholarship is renewable for one year.

**For the following two scholarships only, applications are accepted until July 30, 2010.*

32. Education Opportunities Scholarship* (N/C \$1,000)

Valuing every student's desire to reach higher academic goals, UC Clermont College Enrollment and Student Services awards this scholarship to individuals who have **completed their GED** and are continuing their education at UC Clermont College. Applications are accepted until July 30, 2010.

33. Life Long Learner Scholarship* (N/C, \$1,000)

As an encouragement to those who postponed their college education **a minimum of seven years since graduating from high school**, UC Clermont provides this scholarship to help them realize their dream. Applications are accepted until July 30, 2010.

Aviation Scholarships

34. Ohio National Financial Services Aviation Scholarship (C, \$5,000)

David O'Malley, CEO of Ohio National Financial Services, has a passion for flying and understands the cost associated with this love. He is instrumental in providing this scholarship to **eligible second year aviation students** to assist with flight fees.

35. Phillips Aviation Scholarship (N/C, \$5,000)

Claire Phillips became the first American female corporate pilot in the time when women only went into teaching and nursing careers. Mrs. Phillips, CEO and co-founder of Phillips Industrial Supply, has provided funds to assist with flight fee costs for **academically achieving aviation students** who share her passion for flight.

36. Phillips Aviation Advantage Scholarship (N, \$2,500)

Claire Phillips has provided incentive scholarships for **academically achieving first year students in aviation** to aid them in achieving their aviation goals.

37. Sporty's Aviation Scholarship (C, \$5,000, \$10,000, \$15,000)

The Sporty's Foundation mission is to ensure a healthy, quality aviation workforce for the next generation in the Cincinnati aviation community. This means working with students to create opportunities to learn about more professional aviation careers, expose them to aviation environments and provide opportunities to gain additional flight experience. To aid UC aviation students in this endeavor, Sporty's Foundation provides three scholarships for top aviation students who have **completed their first year of aviation curriculum**.

38. Vorbeck Aviation Scholarship (C, \$5,000)

Joe Vorbeck, former head flight instructor at Sporty's Academy, believed in the quality education received in the UC Clermont Aviation program. The Vorbeck Aviation Scholarship helps **students who have completed the first year aviation curriculum** meet their academic and aviation goals.

Loans

UC Clermont offers three short-term loan funds for students. These interest-free loans are repaid on a pre-arranged schedule with low monthly payments. For application information, contact UC Clermont—Financial Aid.

The Clarence and Martha Ensminger Educational Fund

Loans from this fund are used for tuition and books. Preference is given to students with low incomes and who are from a rural or Appalachian heritage.

The Jim Sauls, Sr. Stay in School Fund

This fund was established in 1992 when local business owner Jim Sauls, Sr. saw students leaving college because of financial emergencies. Designed to be a stop-gap, short-term loan for UC Clermont students—and now funded by local business members—this loan is for expenses other than tuition costs.

The Charles E. Schell Foundation Loan Fund

Loans from this fund assist students with tuition, fees, and books. Preference is given to traditional college students who have a minimum of a 2.0 GPA and face financial difficulties.
